



THE NEED FOR A NEW FOREST POLICY



24% forest cover



– DENR 2003 (uses FAO definition)




Ideal forest cover

- 54% forest cover ideal based on vulnerable slope percentage
 - Dr. Percy Sajise et al. (1996)
- 40% forest cover required to maintain hydrological functions
 - Dr. Rex Cruz, UPLB chancellor (2011)



Current forest policy

- 1904: The Forest Act, Philippine Forest Policy
- 1975: Presidential Decree No. 705
– revising PD 389, Forestry Reform Code
- 1992: NIPAS Act
- 1995: EO 263, CBFM as national strategy
- 1997: IPRA
- 2011 : EO 23, logging moratorium

THE FOREST RESOURCES BILL



Core provisions

- New forest definition
- Protection of all natural and restored forests
- Protection, production, + restoration area
- Watershed continuum-based management
- Devolution of forest management functions



New forest definition

- “An ecosystem or an assemblage of ecosystems dominated by trees and other woody vegetation; a community of plants and animals interacting with one another and its physical environment”
- At least 60% forest cover
 - versus at least 10% of UN–FAO



Protection of natural and restored forests

- Natural: primary and secondary
- Only non-timber forest products allowed to be extracted
- Timber harvesting for subsistence by IPs and local communities in woodlots
- Commercial logging, mining, etc. prohibited



+ Restoration area

- Priority 200m “buffer zone” around natural forests
- Rainforestation
 - DENR MC 2004–06: Guidelines in the integration of rainforestation farming strategy

Devolution

- Phased devolution of forest management functions to willing and able LGUs

Sagip GUBAT network

Sagip GUBAT formally created as a **national network of forest conservation advocates** aiming to:

1. Raise awareness on the importance of forests and the urgency of the FRB
2. Lobby for the enactment of the FRB and other important forest policies
3. Strengthen multi-stakeholder, forest-based partnerships



4. Facilitate CSO participation in forest policy development, implementation, and monitoring;
5. Share information and resources among those engaged in forest conservation-related activities; and
6. Promote integrity in forest governance.
